1. I am of legal age in Missouri and also Illinois if that is my legal residence.
2. I understand that part of the prize money that may be awarded to me is for the purpose of funding my participation in the International Mr. Leather 2010 contest in Chicago, Illinois during the period which includes Memorial Day Weekend, 2010. Check the IML web site for specific dates required. If I choose not to make this trip, or for any reason I am unable to fully participate, the title and prize money may be revoked by GATEWAY M.C. and awarded to whichever contest runner-up is deemed eligible by GATEWAY M.C.
3. For good and valuable consideration, I hereby authorize GATEWAY M.C. to take photographs of me and/or my property, and authorize GATEWAY M.C. and their assigns and transferees to use and publish the same, or other pictures made available to them, including use and publication with my name, no name, or a fictitious name, use in the form taken or with intentional or unintentional alterations, and use for the purpose of publicity, illustration, commercial art and advertising.
4. I understand that this application will be provided to and used by the Judges in their evaluation.
5. I will be mindful of my alcohol consumption realizing that how I come across can impact my scores and image. *Public intoxication at contest/title events could be the basis for elimination.*
6. I understand that there is a zero drug tolerance policy in both the contest and all bars and venues I may attend as a contestant or title holder. *The use of illegal drugs is not permitted and can be the basis for elimination.*
7. I understand that the dressing room provided during the contest will have minimal space, with a mirror available, and no guests. I will provide all of my own personal grooming products and towels if needed. I understand that there will not be water or toilet facilities in the dressing room. I absolve GATEWAY MC and JJ's Bar and all of their staff or agents from liability for loss or damage to any clothes or items that I bring with me.
8. Should I have any special needs or medical conditions that may require assistance, I am checking here \_\_\_\_\_ and I will inform GATEWAY MC with details as soon as possible.
9. I understand that I must always be dressed 'street legal' which includes a 1" rear strap.
10. I will be on time for all events. *Being late could be the basis for elimination.*

Attendance at the Friday Night Meet-and-Greet is expected, but no scoring will take place at that time. Exceptions can be made by GATEWAY MC in advance for individual special needs. Contestants Must Be Available And On Time For All Four Parts Of The Mr. Missouri Leather Judging On Saturday Afternoon and Saturday Evening.

Saturday afternoon – arrive 12:30 - 12:45 for group meeting, interview, rehearsal until 4 PM app.

Part 1: JUDGES INTERVIEW. Individual interviews will start at 1 PM. These will be individual closed door Q&A sessions with the Judges panel.

Saturday night, contestants MUST register in person with Den Daddy at JJ's Clubhouse by 9 PM.

Part 2: CRUISE WEAR. Contestants will be introduced wearing their hottest cruise wear.

Part 3: PHYSIQUE (JOCK STRAP). This is the "posing strap" (street legal) section. Judging emphasizes attitude and carriage rather than athletic shape, and will include an on stage question.

Part 4: IMAGE IN LEATHER. Contestants will dress to display their 'visual image of leather' and speak to the Judges and the audience as to why they would like to be Mr. Missouri Leather 2009.

There is a two (2) minute time limit without reading from notes.

Attendance is encouraged, not required, at winner's brunch Sunday morning and leather ball on Sunday evening.
